YOUR deadline vs. ARCH's deadline — these are not the same date: August 26, 2026 is ARCH's deadline, as Collaborative Applicant, to submit AL-507's Consolidated Application — including the Priority Listing — to HUD. It is NOT the applicant deadline. Your project must be fully and finally submitted in eSNAPS by the date ARCH provides after the CoC Board approves the Priority List on August 14, 2026. ARCH needs that time to verify every project submission and compile the Priority Listing before its own August 26 deadline. A project not submitted by ARCH's agency-level deadline cannot be included in the Consolidated Application — even though HUD's August 26 window is technically still open.

ARCH, as Collaborative Applicant, must submit AL-507's Consolidated Application to HUD by August 26, 2026, 8:00 PM EST — filed in eSNAPS (HUD's system of record). No email submissions to HUD. No late submissions will be accepted.
